These requirements are expected unless specifically addressed by the Purchaser and agreed upon by the Artist.

Hotel Accommodations:

Purchaser shall be responsible for booking and paying for:

- 7 single occupancy rooms at a 4-star or better hotel in close proximity to venue (walking distance if possible) **Please try to arrange early check-in and late check-out when possible.**
- Rooms shall include large beds, air-conditioning, free wireless internet access
- Breakfast to be provided by hotel, if possible

Hospitality (at venue): See below

Tickets/Guestlist:

Purchaser shall make available to Artist ten (10) complimentary tickets for Artist's use for the performance.

Dressing Room/Lounge:

Provide (1) large climate controlled lockable dressing room/lounge area.

- Room should have adequate seating/dining for up to 10 people (chairs/ couches and tables)
- Adjoining PRIVATE bathroom and accessible shower facilities
- Full-length mirror and well lit dressing area
- (10) Clean dry cloth bath towels
- Drinking cups (hot/cold)
- Plastic eating utensils (for up to 10 people)
- 1 Iron & ironing board or steamer

- I Electric hair dryer
- Coffee maker with appropriate filters/pods/k-cups and set up (half & half, milk, honey, Splenda, Sugar, Sweet'N'Low)
- Assorted coffees and teas including decaffeinated selections for both.
- A quality assorted deli meat platter with condiments at load in (mayo, mustard, oil & vinegar) Assorted breads and rolls, lettuce & sliced tomatoes, assorted cheeses, crackers, and fruits

Catering is to be provided:

Purchaser shall provide Artist (5) with 7 full hot meals, which should include at least:

- 2 meat choices (Chicken, Beef, Pork, Fish)
- 2 vegetable choices
- Potatoes/rice/beans
- Bread/ Dinner Rolls
- Dinner salad with choice of dressings
- Dessert

Also requested:

- 24 bottles of water, 12 cold, 12 warm
- 2 (10 lbs.) Bags of ice (provided with clean ice chest)
- Various Pepsi products (regular & diet)

Parking:

Purchaser agrees to provide seven (7) secure parking spaces for Artist's vehicle(s), if driving

Ground Transportation: If the date is considered a fly in date, either ground transportation needs to be provided in the way of a 12 passenger van or a buyout of up to \$500 for a rental.

Backline: 5 Piece drum kit, DW, Yamaha Maple Custom or Pearl Masters, Zildjian cymbals, 17 crash, 18 crash, 19 crash and 21 inch ride, all hardware, and throne. One Bass head with 4 x 10 bass cab, Gallien Kruger, David Eden or GK, 350 watts or more. One Fender Hot Rod Deluxe, 2 x 12, One Hammond XK3c keyboard, one 76 note Korg Triton with two tiered x stand. One 6 string acoustic guitar, Takamine or Taylor preferred. 4 guitar stands, small table or case for laptop. Three fans for stage, drum surround when appropriate.

Security: Purchaser agrees to guarantee proper security at all times to ensure the personal safety of the Artist, auxiliary personnel, equipment and personal property, during and after the performance.
